## TOP FIVE DOs AND DON'Ts Related to Your 2017-2018 Annual Secured Property Tax Bill



1

### Pay online at [lacountypropertytax.com](http://lacountypropertytax.com).

eChecks are **FREE** and you can pay up **until 11:59 P.M. Pacific Time** on the delinquency date. See "Payment Options" on the enclosed insert.

### Wait until the last few days prior to **December 10 or April 10 to pay your bill.**

If you pay close to the delinquency date and something goes wrong, you won't have an opportunity to correct it.

### Utilize self-service options at [lacountypropertytax.com](http://lacountypropertytax.com):

- Locate the amount due.
- Review your payment history.
- Learn to avoid penalties by understanding postmarks.

### Pay your bill using online bill pay services offered by your bank or financial institution.

### Enroll in our new Property Tax Management System.

### Mail your payment without understanding the importance of postmarks.

### Call your lender – not the Tax Collector – with questions on impound/escrow accounts.

Lenders may debit accounts up to several months prior to submitting the payment to the Tax Collector.

### Ignore Supplemental Secured Property Tax Bills.

Most lenders **DO NOT** pay them. See "Information on the Assessment Process – Other Assessments" on the enclosed insert.

### Understand that the Tax Collector has limited authority under the law to cancel penalties.
